

#### **Instructions for GST Payment through CUB Net Banking**

Users can pay GST by first generating a challan from the GST Payment Portal to obtain a unique **CPIN** number.

#### Please find below the instructions to follow.


1. Open web browser and go to GST Portal : <a href="https://payment.gst.gov.in/payment/">https://payment.gst.gov.in/payment/</a> and enter your organization's GST number and the appropriate CAPTCHA code.




2. Select the appropriate Reason for challan payment.






3. Fill in the GST payment amounts, choose payment mode as E-Payment and Click on "GENERATE CHALLAN"






4. Re-enter the GST number and ensure it is the same. Then click on "PROCEED"






5. Once the challan is generated Note the CPIN number





6. After challan generation choose Net Banking and select "CITY UNION BANK LIMITED" by agreeing to Terms and conditions choose "MAKE PAYMENT"



- **6**If amount is deducted from bank account and not reflected in electronic cash ledger, you may raise grievance under Services>Payments>Grievance against payment(GST PMT-07)
- \*Awaiting Bank Confirmation: For e-payment mode of payment, if the maker has made a transaction and checker approval is not communicated by bank to GST System.
- \*Awaiting Bank Clearance: For OTC mode of payment, if bank has acknowledged the challan but remittance confirmation is not communicated by bank to GST System.



7. Ensure the total Amount and Click "PROCEED TO PAYMENT" by agreeing to the terms and conditions.

8. The page will get redirected to our NET BANKING, Choose PERSONAL and login using credentials.




9. After login the transaction screen will appear. Select the account and enter the transaction password then click "SUBMIT"
