Sub: Imposition of Monetary Penalty by Reserve Bank of India

Ref: Intimation u/r 30 of SEBI Listing Regulations, 2015 as amended

We hereby inform that with reference to Statutory Inspection for Supervisory Evaluation of the Bank – position as on 31st March, 2025, the Reserve Bank of India ("RBI") had sustained the following charges against the Bank:

- i. The bank levied loan related charges on certain agriculture priority sector loans up to ₹25,000/-.
- ii. The bank did not report Self Help Group member level data to Credit Information Companies.

On account of the above, the RBI had levied a penalty of Rs.10 lacs and Rs. 0.10 lakh respectively totaling Rs.10.10 lakhs (Rupees Ten Lakhs and Ten Thousand only) on the Bank vide its letter no. CO.ENFD.DECB.No.S137/02-02-002/2026-2027 dt.22-5-2026.

The details required to be disclosed as per Para A of Part A of Schedule III of the SEBI Listing Regulations, read with SEBI Master Circular No: HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30, 2026 is enclosed.
